### Payments and Credits:

Terms are NET 30 DAYS unless different terms are otherwise required by Seller. Any unpaid balance shall accrue a monthly interest charge following its payment due date at the annual rate of 10%. In the event that an attorney is employed by the Seller to collect all or any portion of the unpaid balance, Customer agrees to pay Seller's reasonable attorneys' fees and costs of collection, whether or not a suit is commenced. Payments by check should be made payable to **Care Living Diagnostics Inc.**

Orders must be **pre-paid** if paying by credit card. We accept **MasterCard, Amex, Discover** and **Visa** at the time of shipping.

### Shipping:

We offer Next Day shipping on all orders over \$1000.

Any damage or shortage of product received **must be notified to us within 2 business day of Delivery.** It is recommended that customers insure all return goods shipments. Care Living Diagnostics Inc is not responsible for shipments lost in transit. It is the customer's responsibility to ship product in accordance with local, state and federal regulations.

### Returns:

Full credit will be given for shipping errors and products damaged in transit, provided the error or damage is reported to us within 24 hours of receipt of the product. All returns must be authorized in advance by contacting customer service and obtaining an authorization. We reserve the right to charge a **20% restocking fee.** Credit issuance is dependent on confirmed receipt/review of returned goods. Returns received with outdated/invalid authorizations will be handled as unauthorized returns and destroyed without credit.

### Guarantee:
